#### University / College Update

- A. Co-op credit weight change
  - 1. Recognize the value of academic activity and work-integrated learning that happen through co-op.
  - 2. COOP\*1000, 2000, 3000, 4000, & 5000 change credit weight from 0 to 0.50, effective May 2019.
- B. SoCS applications for CRC tier-2 were not successful.
  - None of the three positions of UofG is allocated to CEPS.

#### **Faculty Hiring**

#### A. Al faculty hiring

- 1. Cmt: Stefan, Stacey, Mark, Luiza, Andrew Gadsden, and Yang
- 2. Search Cmt has determined job description for posting.
- 3. Once approved, it will be posted for 60 days.
- Collective Agreement on Chair of Faculty Search Cmt:
   "The Search Committee shall consist of: the Chair; three (3)
   Members from, and elected by, the Department; and up to two (2) persons appointed by the Chair."
  - "Chair shall mean the duly appointed Chair of a Department or Director of a School."
- 5. The new Director will take over Chair of Search Cmt in May.
- B. Retirement replacement position
  - 1. Replacement position has been approved.
  - 2. Hiring will be lead by new Director.

#### Cyber Lab Setup

- 1. With the approval of Master of Cybersecurity and Threat Intelligence (MCTI) program, the SoCS effort is shifted to being ready for F19 enrolment.
  - Conservative enrolment projection: Yr 1: 20; Yr 2: 25; Yr 3: 30;
- 2. Major tasks
  - 1. Cyber lab setup
  - 2. Marketing and outreach (Joe)
- 3. Update on cyber lab setup
  - 1. Estimate funding need (server, in-lab eq, tech support)
    - Ali, Joe, Kyle, Dana, other cyber faculty, and CCS staff
  - 2. Request funding
  - 3. Equipment purchasing and installation

## **Cyber Lab Funding Options**

- A. Full capacity for cyber server and lab equipment
  - 1. Total 1st year funding: \$327K
  - 2. Can admit to full capacity of 36 students in 1st year.
- B. Reduce lab equipment for fewer students
  - 1. Total 1st year funding: \$308K
  - 2. Cannot admit more than 25 students in 1st year.
  - 3. Need to scale up lab equipment in 2nd year.
- C. Reduce server capacity & lab eq for fewer students
  - 1. Total 1st year funding: \$273K
  - 2. Cannot admit more than 25 students in 1st year.
  - 3. Need to scale up both server & lab eq in 2nd year.
