Proposed Summer Co-op Schedule

What the Co-op Office wants

- the first work term should not be in the Summer semester
- no more than two Summer work terms
- four or five work terms
- eight month work terms
- the last semester cannot be a work term

Previously agreed to changes which should be implemented

- moving CIS*1910 and CIS*2910 to semesters 1 and 2 respectively
- adding CIS*3490 to the Software Engineering major

An opportunity that we can pursue because of these changes

- fix the sequencing of CIS*3750 and CIS*3760 so they are available in the correct order to all students
- this can be done as part of the reordering of courses for Co-op



Other changes we might wish to consider:

- a version of CIS*I 500 only open to B.Comp. majors which is now "free" because of the increased class size
- a Summer offering of CIS*2750

Revision of Draft Regulations on QE and Seminar

- Processing completed
 - 1. Regulations on QE and seminar were drafted and approved by Grad Curr Cmt in July 18.
 - 2. They were distributed to faculty for commenting (July 18 to July 21).
 - 3. The drafts were revised by Grad Curr Cmt to address faculty comments (July 22 to July 28).
 - 4. The revised drafts were sent to faculty on July 28.
- Objectives of this presentation
 - a) Report major issues discussed and major revisions made by Grad Curr Cmt
 - b) Seek SoCS faculty approval of both regulations

Revised Draft on QE (1)

- Recommendation from Adv Cmt on student potential as a researcher and research performance before QE
 - ☐ Consistent with Calendar; Integrated in QE request form;
- On inclusion of both Written and Oral Components
 - ☐ The written component on learning modules is a nontrivial component of the approved PhD Proposal.
- On dependence between the two Components
 - 1) Both will be conducted for each student.
 - 2) Outcome of each will be decided when both are done.
 - 3) A pass of the QE requires a pass for each component.

Revised Draft on QE (2)

- On the form of the Written Component
 - ☐ One written test per required learning module (max 2 hrs)
- On written test questions
 - ☐ Intention: Module developer includes a test question library.
 - ☐ Regarded too detailed and removed from Regulation
- · On the length of Oral Component
 - ☐ Presentation: 30 min; Questions: max 90 min;
- · On closed questioning period
 - ☐ Trade-off: Well-being of the candidate vs learning opportunity to other students

 - 2) Removed requirement on non-Adv Cmt membership
 - 3) Must be chaired by one of the co-Advisors
