Overview

Slow Data will be a deep dive into the problems of data usage in analysis, machine learning, etc. because of bias, lack of metadata, provenance and other documentation, improper collection and problems with crowd sourcing and using low paid humans to classify or label data in large data sets, low quality, poor usage of metrics and analysis, problems with findability, accessibility, interoperability, and reusability (FAIR principles) and CARE (indigenous data usage principles), openness spectrum, and semantic interoperability. It is called Slow Data because this is a look at slowing down the pace of data set usage until these issues have been explored and documented.

This course will be of interest to students that are doing research where they have to create or search for and use large data sets. It will involve programming in Python mainly. There will be a large number of papers assigned to read and the deliverables will include a literature review, programming exercises, and a small project (individual or group depending on the size of the class).
