Description: Recent advances in big data technologies has brought us to a unique time in human history. The impact of such technologies is now evident in our economy, civil liberties, food production, healthcare, education, and many other aspects of our society. The goal of CIS*6650-Big Data course is to equip students with technical and intellectual skills to tackle emerging challenges and opportunities of Big Data.

This course provides an overview of big data technologies and their implications. It covers big data principles, the state-of-the-art methodologies for large data management and analysis, and their applications to real-world problems. To this end, it briefly reviews data mining techniques such as data cleaning, data analysis algorithms, and approaches such as predictive, perspective, and descriptive. The course also focuses on Big Data management and analytics techniques and provides hands on experience with tools such as Hadoop, Spark, Map Reduce or other tools.

Furthermore, this course reviews Big Data emerging applications such as social computing, smart cities, smart cars, military, and many more. Lastly, Big Data technologies implications will be extensively discussed in the class.
