Course Objective and Topics

The objective of this course is to teach theory and techniques for designing and analyzing computer algorithms for solving problems, and many commonly used algorithms. The design techniques include divide-and-conquer, decrease-and-conquer, transform-and-conquer, dynamic programming, greedy techniques, iterative improvement, backtracking, and branch-and-bound. We discuss algorithms for manipulating data structures of lists, matrices, trees, graphs, etc. and for solving problems like sorting and searching. We also study mathematical methods for analyzing non-recursive and recursive algorithms, and discuss the problems of NP-completeness.
