Marking Scheme - Revised due to COVID-19

1. Programming Assignments: 50%
2. Midterm Examination: 20%
3. Optional Take-Home Examination: 30%

If you choose to write the optional take-home examination then your final grade will be calculated by summing all of the grades for the assignments one to four, midterm, and the take-home exam.

If you choose to not write the take-home final exam then your grade will be the sum of grades earned from assignments one to four and the midterm calculated out of 70 (50% assignments 1-4, and 20% midterm). In this case the midterm and assignment grades will be summed and divided by 70 (and multiplied by 100) to calculate your final grade in the course.

Notes:

- All assignments will be posted on the Courselink page.
- The course is divided into two section, the first is the (Midterm Exam + Final Exam) and the second is the Programming Assignments. You must achieve a passing grade in each of the sections to pass the course. A failing total in either of the above two sections will result in a final grade in the course equal to that failing total. The highest grade you can achieve if you fail either section is 45%.
- There is no group work in the course. It is academic misconduct to collaborate on assignments or represent other student's work as your own. There are penalties for doing this. All submitted code will be electronically checked for cheating. All parties to cheating will be reported to the Director of the School of Computer Science as participants in academic misconduct. - Code which is submitted and does not compile will be given a mark of zero.
- Failure to submit assignments correctly will result in a substantial loss of marks. Assignments will be submitted through the Courselink site.

This course is an introduction to computer graphics. Topics include graphics programming concepts, geometrical transformations, viewing 3-D projections, raster graphics, sculptured surfaces, visible surface determination, image processing and other special topics.
